Mark now works as a cybercrime and open source intelligence consultant and trainer to the UK Home Office, the City of London Police, the UK National Police Chief's Council, CISI, WMA, ICA, MISTI, CIFAS and several other organisations. He has previously delivered international engagements for the United Nations and Europol

About the exam

Managing Cyber Security is examined via computer based testing and exams take place throughout the year. The exam consists of 50 multiple choice questions and lasts 1 hour.

All participants will be awarded a certificate of attendance. Each hour of attendance will account for one unit of Continuing Professional Development (CPD) as required for members of most professional bodies.

Who should attend

The syllabus is primarily intended for non-technical and managerial audiences and is suitable for professionals working within the financial services industry including Compliance officers and Money Laundering Reporting officers, those involved in operational risk management, audit or IT audit, regulation, law enforcement, trade and commerce and individuals from bi-lateral development institutions and civil society organisations.

Key features:

This exam can be taken as a stand-alone award or as a unit of the Investment Operations Certificate (IOC). It has also been designed to complement our Combating Financial Crime qualification. Candidates who take both qualifications will be awarded the CISI Level 3 Certificate in the Prevention of Financial and Cyber Crime.

When combined with the CySEC Examination, candidates will be awarded the CISI Level 3 Certificate in Managing Cyber Security. In addition, candidates who combine Managing Cyber Security with the IT in Investment Operations exam will be awarded the CISI Level 3 Certificate in Cyber Security and Information Technology in Investment Operations.
